

The first rector of the Higher School of Commerce - Professor Tsani Kalyandzhiev was the first Professor of Commodity Science in Bulgaria. Already 65 years the Commodity Science Department is the only national center for training specialists with higher education in the field of quality and expertise of goods.

You are cordially invited to take part in that most significant scientific event within the realm of quality in commodity science held biannually. You are kindly invited and welcome to participate in the panel and discussions as well as to enjoy the ambience of Varna, the Summer capital of Bulgaria.

TOP 1 - 5: OPENING / ACCOUNTING THE VOTES/APPROBATION OF THE AGENDA AND MINUTES OF THE LAST ASSEMBLY, REPORTS OF THE PRESIDENT/VICE PRESIDENTS

President Prof. Maria Claudia Lucchetti welcomes the Executive Board and the country delegates of the IGWT stating the due convening. Prof. Zenon Foltynowicz moderates the assembly.

With reference to §10 and § 12 of the charter, and after discussion on the number of Korean Society votes, the total number of votes was counted (27 votes – Appendix 1).

The motions for the approval of the agenda for the 19<sup>th</sup> general assembly and of the minutes of the 18<sup>th</sup> General Assembly in Roma, Italy 27<sup>th</sup> Sept 2012 are passed unanimously.

Professor Luccetti reports on the activities during her presidency. She outlined her attempt to organise an expert system of IGWT members. It hasn't brought expected results yet but she expressed the hope that it is still worth of attention.

The Pre-President Professor Andrzej Chochol thanks the IGWT members for the engaged participation in the present 19<sup>th</sup> symposium on the topic "Commodity Science in Research and Practice. Current Achievements and Future Challenges". The symposium brought together 180 academics, researchers and experts from 15 countries all over the world. He declared his help in organizing the next Symposium and the transfer of the IGWT website to a Polish domain in order to amend and restyle it.

#### New § 14 4 SPECIAL RESPONSIBILITIES OF THE VARIOUS MEMBERS OF THE EXECUTIVE BOARD

If the position of an Executive Board member becomes vacant due to death or voluntary resignation, or if an Executive Board member is prevented from performing his or her duties in accordance with the Charter, this member **shall be replaced by cooptation** in case of death or voluntary resignation until a new member is elected at the next ordinary General Assembly meeting, and in case of prevention until prevention has ceased, but at any rate no longer than until the prevented member's term of office expires or until a new member is elected at the next ordinary General Assembly meeting

The financial position of the IGWT is quite stable, fluctuation due to subsidising the biannual symposia. The  $19^{th}$  symposium was sponsored with  $5000 \in$ .

However, the treasurer requests the reports on the number of members in the national societies and the corresponding balancing of outstanding membership fees.

#### **WE CONGRATULATE**



Prof. DDr. Günter Grundke \* 26. March 1925



Prof. Dr. Josef Hölzl
\* 28. September 1925

**Professor DDr. Günter Grundke¹** was born on March 26th, 1925 in Maltsch, Silesia. In Breslau he attended secondary school and begun studies of natural sciences. Interrupted by military service and Soviet war captivity he was able to continue his university studies in 1947/8 at the University of Jena. He graduated in chemistry, physics and geography and received a doctor's degree "summa cum laude" by the Friedrich Schiller University in Jena in 1953. The topic of his thesis was about the importance of climate for industry sites.

In 1953, he established the Institute for Commodity Science at the Hochschule für Binnenhandel (Academy for Domestic Trade) in Leipzig. He was nominated as director of this institution and became professor for Commodity Science. He received a further degree "summa cum laude" with a thesis on the development and functions of commodity science in 1955.

Starting from 1953 until his retirement in 1990 he was continuously teaching commodity science and technology in many German universities and abroad:

1953 – 1962 – Hochschule für Binnenhandel , Leipzig, DE; 1963 – 1969 University of Leipzig, DE; 1970-1990 Handelshochschule (Academy of Commerce), Leipzig; 1965 – 1990 Technical University in Merseburg, DE;1974- 1998 Economic University in Cracow, PI

As visiting professor he held courses and lectures in Poland, Bulgaria, Hungary, Romania,

former Soviet Union and Czechoslovakia, Austria, Italy, Japan, China, and South Korea.

He developed all kinds of teaching material for Commodity Science (commodity samples, pictures, films, work sheets, etc.) and his study books on Commodity Science were used far beyond the German speaking world.

His expertise on commodity maintenance, transport, damages and packaging became not only valuable for his students. His cooperation and expert opinion in these fields were highly estimated by state offices and stakeholders of industry and commerce alike. Prof. Grundke is author of more than 600 publications and contributed essentially to international standardization by his expert experience and scientific work.

After retirement from university in 1990, he promoted together with Dieter Berndt the foundation of the German Packaging Institute (dvi Deutsches Verpackungsinstitut e.V,) as a network for the packaging industry. There he was actively involved in qualification programs and international cooperation for the years to follow. In 2000 he published a revised lexicon on commodity damages and up to date he delivers contributions for journals and conferences. Professor DDr. Grundke received many awards and of cause he is an honorary member of the IGWT.

Personally I had the honor to meet and talk to Prof. DDr. Grundke several times over a long period. Always he impressed me by his outstanding integrity, knowledge and diligence.

**Professor Dr. Josef Hölzl** <sup>2</sup> was born on September 28<sup>th</sup>, 1925 in Ybbsitz, Austria. After grammar school, during the Second World War, he had to serve in the air force and was under Soviet war captivity. From 1947 to 1952 he studied at the philosophical faculty of the University of Vienna natural sciences and philosophy. In 1952 he was accredited to teach biology, philosophy and physics in grammar schools.

His main interests at that time were devoted to plant physiology and ecology resulting in a thesis on plant physiology (1954). In 1955, he became a research assistant and later - until 1972 - a university assistant at the Institute for Botany, Technical Microscopy and Organic Raw Materials of the Technical University of Vienna. There he worked on the methodology of microscopy, investigating pant physiology, and on new horticultural techniques to enlarge animal and human food amplitude. In 1965 he attained a postdoctoral lecture qualification in botany as a professor titular due to his habilitation on botany under special consideration of technical utilization of natural raw materials. From this work derived his highly appreciated study book on the introduction to organic raw materials, which he wrote together with his famous doctor father Prof. Dr. E. Bancher.

From 1971 to 1984 he was head of the Institute for Botany and Food Science at the Veterinary University in Vienna and only one year later he became head of the Institute of Technology and Commodity Science at the Vienna Economic University (WU), a position held until 1991. His main activities switched to promoting Technology and Commodity Science within the economic curricula in order to bridge preconceptions

between natural and social sciences. Based upon his unusual interdisciplinary view Prof. Hölzl introduced life cycle perspectives of products, system theory and attached great importance to environmental perspectives long before sustainability has been observed by mainstream economy.

He was eagerly engaged in international cooperation at a time Europe was still divided into East and West and he was especially interested in Asian cultures. Thus he was among the initiators of IGWT foundation in 1978 taking place in Austria and launched, together with Dr. Gekeler from Germany, the issue of the German Journal Forum Ware in 1972. He was president of the IGWT for many years.

The scientific heritage of Professor Hölzl comprises about 150 publications on microscopy, plant physiology and organic matter as well as Technology and Commodity Science.

Knowing Prof Hölzl since my study period, later as doctor father and boss at the Veterinary University and having met him lately, on the occasion of celebrating his 90 birthday, I still admire the universal philosophy on the biology and economy of mankind of this modest and educated man.

In 2015 IGWT lost two very important members, who had shaped the development of Commodity Science over decades: Jacek und Anna Koziol. In their private and scientific lifes they were closely tied together and it seems to be more than a mere coincidence, that they both passed away within a few months.

**Prof. dr hab. Jacek Koziol** <sup>3</sup> died on May 11<sup>th</sup>, 2015. He was professor and lector at the Poznań University of Economics and Business. There he was among the founders of the Faculty of Commodity Science and for many years, he held the position of the Dean of the faculty. Numerous high-ranking positions and awards are evidence of his engagement and importance in university life and education. The article below gives a good impression of his merits.

As a president and vice-president of the IGWT we remember the passion for commodity science, which Professor Jacek Koziol demonstrated in conferences and meetings.

**Prof. dr hab. Anna Kozioł** <sup>4</sup> passed away on August 20th, 2015. She was Assistant Professor and lecturer at the Poznań University of Economics and Business. Her research was devoted to active agents in natural substances, photochemistry, instrumental analysis and the investigation of product quality.

Anna Kozioł held a number of higher positions within and outside university and was member of many scientific associations, among them IGWT. She received distinguished awards from her university and from the Polish Ministry for Education.

LAUDATION FOR PROF JACEK KOZIOL BY PROF. DR. BOŻENA TYRAKOWSKA ON THE OCCASION OF HIS **70**<sup>TH</sup> BIRTHDAY

In this article, written to celebrate the 70th birthday of Professor Jacek Kozioł, I would like to express, on behalf of the academic community and myself, our gratitude and respect to Professor Koziol not only for his scientific and teaching achievements but, above all, for his remarkable contribution to the creation and development of modern commodity/quality science at the Poznań University of Economics and in Poland. Professor Jacek Kozioł has been involved in commodity science at the Poznań University of Economics for 50 years. In the years 1949-54 he studied commodity science, and in 1952 he started working for the Chair of Food Commodity Science under the supervision of Prof. Aleksander Lempka, an eminent commodity science specialist.

Since 1979, when he was appointed a professor, he has been specialising in quality development, protection and assessment. He is widely recognised as an outstanding chemist and commodity science specialist, both in Poland and abroad. Professor Kozioł is notable for his courage, determination, consistency as well as a deep love of and dedication to the scientific disciplines he pursues. These qualities, which are his guiding principles he has striven to instil in his disciples.

One of Professor Kozioł's life passions is the research of flavins. He got his PhD degree upon presentation of a thesis on fluorescence of flavins. After receiving the degree, he started developing his own research programme concerning physical-chemical and photochemical properties of vitamin B2 derivatives. In 1969, he undertook his first long-term postdoctoral fellowship and he worked with Professor David Metzler at the

Department of Biochemistry and Biophysics at Iowa State University. There he started his first international contacts, which initiated a long-lasting and fruitful co-operation with many outstanding scientists. Having returned to Poznań, he created his research team, and in 1976 founded the Chair of Instrumental Analysis. The results of his research, published in prestigious journals of world-wide circulation, invariably arouse a lot of interest. Professor Kozioł's team has published numerous scientific papers in co-operation with well-known British, Dutch, German, Italian, Japanese and American authors specialising in photo-chemistry and biochemistry of flavins. Professor Kozioł and his team brought a significant contribution to the knowledge of chemical, photochemical and photo-physical properties of derivatives of flavins with alloxazine structure. His most important achievements include: the discovery and explanation of the phenomenon of isomerisation of alloxazines in excited electronic states in the presence of various compounds catalysing "concerted double proton transfer in excited states". He also solved the mechanism of the so-called covalent hydration of alloxazines in aqueous alkaline solutions, proposed an interpretation of the electronic structure of alloxazine and its derivatives with various substituents, and provided an explanation of the effect of hydrogen bonding on the spectral properties of isoalloxazines and alloxazines.

As a chemist and commodity science specialist, Professor Kozioł has always paid much attention to the problem of quality in general and to the application of modern instrumental analytical methods in evaluation of the products' quality. His remarkable achievements in the field of commodity science analysis include establishing criteria for the selection of analytical methods and schemes for the determination of constituents present in products in trace quantities, e.g. group B vitamins. He also supervised the introduction of reliable instrumental methods for food product quality assessment into Polish Standards.

Since 1985, the issues connected with a broad social aspect of quality have played an increasingly important role in Professor Kozioł's scientific research, becoming, next to research on flavins, his other life passion. He has often been invited to work in teams of experts. He has won acclamation for his standpoint on the determinants of quality, losses resulting from poor quality, significance of basic research for development of commodity science, the role of commodity science specialists in the promotion of good quality, organisation of quality control, and the significance of modern technological achievements in the education of economists and commodity science specialists.

Professor Kozioł's team has developed into a school which is, as Prof. Dr. Maciej Wiewiórowski, an outstanding chemist; aptly put it, an original hybrid of physics-chemistry, photo-chemistry, and molecular spectroscopy and commodity sciences.

The authority of Professor Kozioł as an outstanding chemist and commodity science specialist has been supported by over 100 papers on vitamins, quality assessment and implementation of quality priority, published in Polish and foreign scientific journals. He has also been an organiser or participant of numerous conferences and symposia held in Poland and abroad, presenting the results of research conducted by his team and the achievements of Polish commodity science.

He is an excellent lecturer and teacher. He currently lectures on food commodity science and technology, human nutrition, quality and ecology, and trends in commodity/quality sciences. He inspires and stimulates the scientific research of his disciples and coworkers, at the same time creating opportunities for them to achieve their aims and assess their own abilities. Thanks to the Professor's personal contacts and position, the staff of the Faculty of Commodity Science received long-term fellowships abroad and vice versa, eminent Polish and foreign specialists visit the Poznań University of Economics to conduct consultations and give lectures, all of which results in various co-operation agreements.

Professor Kozioł has held numerous responsible positions at our Alma Mater and outside. For many years, he was the Dean of the Faculty of Commodity Science. The Faculty owes to his activity at that time its modern programme of education. At the beginning of the

1990s, he was invited by the Ministry of Education to be one of the few experts responsible for establishing the programme minima for disciplines within the curricula proposed for studies in economic sciences. He was responsible for the programme minima for commodity science at the baccalaureate and master's levels. These minima are obligatory for all university-level schools in Poland offering education in commodity/quality sciences.

In the years 1999-2001, the Professor was President of the International Society of Commodity Science and Technology (IGWT). At present, he is Vice-President and one of the Editors of the International Journal for Commodity Science "Forum Ware International", Vice-Chairmen of the Polish Commodity Science Society, President of the Commission of Commodity Science and Quality Science of the Polish Academy of Sciences (Poznań branch), and a member of the Polish Chemical Society, the Polish Biochemical Society and the European Photochemistry Association.

For his research and teaching work as well as his contribution to education, Professor Koziol has received many prestigious awards and honours from the Polish authorities (including high orders such as Krzyż Kawalerski Orderu Odrodzenia Polski, Krzyż Oficerski Orderu Odrodzenia Polski and Medal Komisji Edukacji Narodowej/ The Medal of the National Education Committee).

Professor Jacek Kozioł is a co-founder of the Faculty of Commodity Science. In 1993, thanks to his long efforts, the Faculty of Commodity Science was the first in Poland to be awarded full academic rights in the field of commodity sciences. The unique curriculum introduced at that time is a well-balanced combination of sciences and economics. The Professor's open and humanistic personality, the qualities of his character and mind, and his broad scientific and organisational activity as the Dean of the Faculty of Commodity Science at the University of Economics have had a significant impact on the shape, importance and rank of commodity science studies not only in Poznań or in Poland, but also in many academic centres throughout Europe.
